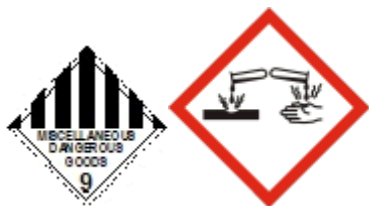

Inhalation
